ECVP 2022 | Frequently asked questions

Registration

Q: I recently obtained my master degree and I am now a Research Assistant, which type of registration fee I should pay and which documents I should upload?

A: You can register as a student and you can upload a copy of your Master's Degree with your registration in the EasyChair registration system.

Grants and funding

Q: The registration fee is a large amount for me. Can you give me a discount?

A: Unfortunately we can't. We highly depend on the fees paid by the participants. You can always apply for a grant, more information can be found on our website: https://2022.ecvp.eu/awards/.

Payment and Invoice

Q: Can I transfer the money to a bank account-number?

A: No, for the registration we make use of EasyChair, and therefore we only accept credit or debit card payments.

Q: Can I get an invoice?

A: Yes, you can download the invoice (itemised or single price) with the payment options yourself when you go to registration data and then click "download invoice" at the top right. There you can also find how to pay.

Q: Can you add other information to the invoice?

A: No, the invoice is drawn up by the registration program EasyChair, therefore it isn't possible to add information to the invoice.

Abstracts

Q: How should the abstract be submitted?

A: You can submit the abstract via EasyChair, you can use the following link: https://easychair.org/my/conference?conf=ecvp2022

Q: I'm part of a symposium that has just been accepted. Can I also submit an abstract for a 'standard' presentation on an unrelated topic?

A: Yes, in addition to the symposium, you can submit one other abstract as the first author. The number of co-author abstracts is (as usual) unlimited.

Presentations

Q: What if, last-minute, it appears that I cannot present: is a presentation via zoom possible? A: No, this is an in-person meeting. A colleague or co-author can present.

Q: What if, last minute, I cannot present, can I get my fee back?

A: No, after July 15th there is no reimbursement (see our cancellation policy: https://2022.ecvp.eu/registration/)

Health measures

Q: What are the requirements concerning the health measures for attending the conference? **A**: Regarding Covid-19, we adhere to the government measures that apply at that time. At this point in time, there is no check on health certificate at the conference itself. We will inform you if this changes. We advise you to look into the rules and measures that apply with regard to travelling to the Netherlands from your country. These rules and measures can vary from country to country and from the type of transport you choose.

Q: Can you send me a COVID Secure Policy or COVID risk assessment for the conference? **A**: We adhere to the COVID-19 measures that apply at that time. At this moment there are almost no restictions: no limit on group sizes, no obligatory mouth masks. You can find an up-to-date description of the rules and measures on the <u>university website</u>.
